ABSTRACT SUBMISSION

Abstract (up to 250 words) should contain the Title, name and surname of all authors, affiliation of all authors, address, phone/fax numbers, email address of corresponding author.

Abstract should be structured: Aim (of the study), Methods, Results (main, with numbered data), Conclusion (basic); 3-5 key words should supply.

All Abstracts will be published in Abstract Book.

Authors with accepted Abstracts will have an opportunity to publish their research papers (in extenso) in regularly issue of Southeastern European Medical Journal (SEEMEDJ) Vol 5. No 1. (2021) (<http://seemedj.mefos.unios.hr/index.php/-seemedj>), and authors kindly ask to prepare their manuscripts according to Guidance to Authors for publishing in SEEHSJ (<http://seemedj.mefos.unios.hr/index.php/seemedj/about/submissions#authorGuidelines>), and send us after acceptance of Abstract for Congress.

We accept the research papers that have not been published yet, in the article categories: Review, Original article, Professional article.

Up to 01 August 2020 – Abstract submission

Up to 31 December 2020– submission of the paper

All abstracts should be submitted by E-mail: kmldfbih2020@gmail.com and mark it as "Oral presentation" or "Poster presentation" (Abstract submission).

Scientific committee holds the right to decide how submitted abstract/paper will be presented.

All abstracts will be reviewed by the Scientific Committee, and a notice of acceptance will be sent to the submitting authors until the deadline. Further instructions will be sent to the authors whose abstracts are accepted.
